MESSAGE FROM THE BOARD PRESIDENT

Your Board of Directors and management in concert with our legal counsel have decided to cancel the Annual Members Meeting scheduled for April 11th, 2020. This decision was reached as a result of acknowledging the reality of the global pandemic and the impact it has on all of us.

At Maisons-sur-Mer we have acted in many ways to enhance the safety and protection of homeowners/residents:

- We immediately increased the level of handwashing of all staff and antibacterial wipe down of common areas, entranceways, elevators, etc.
- Employees who have a fever or any signs of illness will stay home until they can determine they have a cold/flu/etc., or have waited 7-14 days for passage. We will determine if they were in contact with other employees or owners / residents and make them aware to be monitoring for sign of virus and contact with others.
- 3. We have announced that if any owners are determined to have COVID-19, we must be advised by the owner or health service provider. While protecting the confidentiality of the owner, we will take all precautions to sanitize all areas they may have contacted and identify any employees or owners/residents they may have been in contact with so they can take the necessary protective measures.

- 4. We continue to monitor the guidelines and mandates of our Governor, state and county officials. Through their directives all pools and amenity rooms have been closed, all social events canceled and the Bon Appetit limited to take-out and selective delivery thereby ensuring the continuation of food service as long as our staff remains healthy. Owners and residents may still access the beach from the Maisons beach access as it is considered a private access.
- Security of our building continues with the assurance of our security company that support will be provided if any of our current staff become ill.
- 6. We ask all owners to be cognizant of our older residents and recommend reducing visitors, rental unit activities, contractors, vendors, etc. to minimize any possibility of introducing the Coronavirus into our building. Similarly, in all interior open common area rooms, groups are restricted to 3 or fewer individuals practicing 6' social distancing.

Management and staff continue to conduct the operation of the Maisons in compliance with current guidelines. Be assured that your Board will monitor the situation constantly and at an appropriate time will reschedule an Annual Meeting. In the meantime, your current BOD will serve your interests until an election can be held.
